- Vendors will check in at tent going into Wiseman Park. You will receive a vendor pass for your vehicle and event schedule. You will be assigned your booth space/spaces. Vendor parking is available.

- No parking allowed on the square. No vehicles on site. If handicapped you must call ahead for parking approval.

- Vendors are expected to remain open until at least dark on each day.
