Dear Prospective Vendor:

On Saturday, October 24, 2010, Lynchburg, Tennessee will host an anticipated 20,000+ visitors to the **22nd Annual Jack Daniel's World Championship Invitational Barbecue**. Along with this prestigious competition, the Metropolitan Lynchburg/ Moore County Chamber of Commerce is happy to invite a limited number of artisan vendors to the event. We appreciate your interest and invite you to apply for one of the limited booth spaces.

All booth spaces for artisan vendors will be selected and assigned by the chamber vendor committee. To be considered, you must submit photos of your set-up and items.. Pictures **cannot** be returned. **If selected**, you will be notified by the Chamber. At check-in, you will be informed of your location and setup instructions. Since spaces are limited, priority will be given to vendors with handcrafted items.

The Chamber has installed electrical panels and outlets around the courthouse. We are discouraging the use of generators and can provide adequate electricity to those who require it. There will be an additional charge. The spaces around the courthouse will now be reserved for vendors using electricity. (Note: Vendors will be required to use approved yellow extension cords and will be inspected by a Chamber Representative. 30 amp service is available but very limited and should be pre-approved.)

On the Square:

Per 10 x 10 booth on the Square – Paid before October 1 - \$110.00 (no electricity)
Add \$25.00 per 20amp plug required (limit one per space)
Add \$65.00 per 30amp plug required

- Paid after October 1 - \$175.00 per space

Set-up times: Friday night – October 22, 2010, from 6-8 p.m. (No set ups prior to 6pm will be allowed)
Saturday – October 23, 2010, from 6-8 a.m.

All vendors must be set up with vehicles off the square before 8 a.m.

Fees are non-refundable and non-transferable and must be paid in advance

The competition goes on rain or shine, as do the free tours of Jack Daniel Distillery.
