

2025 Lynchburg Chamber of Commerce Vendor Application
Jack Daniel World Championship Invitational BBQ
October 11, 2025

- Vendors will need to submit pictures of their setup and products with the application to be approved.
- The event goes on Rain or Shine. **There are no refunds.**
- Set-up times will be Friday night from **6:00pm-8:00pm (Friday is NOT an event day)** or Saturday morning from **7:00am to 8:00am**. Please do not enter the event area for setup before 6:00 on Friday night. The Sheriff's Dept. will be trying to close the town square and clear the area for the event. Vendors will be allowed to line up at the entrance at 5:45.
- Vendors will receive an email confirming their acceptance and include a vendor window display by October 1st. You must have this in your car window to enter the area on Friday night or Saturday morning. There are multiple stopping points—the display will help expedite the entrance times. Your space assignment will be given to you as you check in. Each space is a 10x10 uncovered area around the Town Square and through the parking lot of the County Building at the entrance of Wiseman Park. Locations will be determined by the type of product sold and availability
- **All booths must be tent/canopy type booths. Food spaces are reserved for approved vendors.**
- Each 10x10 space is provided at \$75 per space \$100 for food vendors.
- Electricity is available on a limited basis and there is an additional fee of \$25 per 20A plug. These are in the Town Square.
- **Food spaces are reserved, and all food vendors must be pre-approved.**
- The event on Saturday is typically run from 9:00-5:00. The Sheriff's Dept. will remove the roadblocks and allow vendors to pack up when the crowd has subsided, and it is safe to drive in the area.
